## Member Spotlight

Meet Teresa Johnes, veteran in the field of Family Strengthening and Co-Chair of the CFRA Networks Committee. Teresa, has worked in the field for over 24 years, and retired in early 2019. She has worked for nonprofits and most recently for First 5 Santa Barbara County, where for 12 years, she was the Program Officer of the countywide Family Support Focus area. Teresa enjoyed her work at First 5, a school readiness organization focused on families with children birth to five. In this role, Teresa was able to influence systems that support children and families through projects with local and state partners on topics including: Supporting Fathers, Family Development Matrix, Developmental Screenings, Child Welfare's Differential Response, Protective Factors, Vehicles for Change, Packard Foundation's FRC Landscape, Adverse Childhood Experiences and the Standards of Quality for Family Strengthening a baseline for min/high quality in family support programs, which have now gone nationally to over 30 states.



Teresa was also the catalyst for creating the Network of Family Resource Centers of Santa Barbara County, a local network recognized for quality practices, training & technical assistance and capacity building of Family Resource Centers.

*"As a field we need to unify across the state to continue to be the champions for children and families, and this is done by working together across the state so that we can have a greater impact and influence."*

Teresa is also proud of the contributions she has made to the field of Family Strengthening that are helping to shape the field around the state, more specifically, her role as one of the original

cofounders of the California Family Support Network (previously the Network of Family Strengthening Networks), a subcommittee which now sits under the California Family Resource Association (brokered by her and Debbie Comstock who both serve as current Co-Chairs). The CFRA Networks Committee is comprised of experts in the field from across the state, and currently meets monthly and is working behind the scenes with a focus on three C's:

1. Convene the field in best practices
2. Communicate and share updates, that support moving the field of family support forward
3. Connect leaders from networks for moral support, program guidance

The Pandemic, has placed a hold on many activities, but the committee is working on how to engage members in different ways, more to come on this!

While Teresa is retired, and is a self-described music junkie, loves traveling and camping, she continues to have a passion for the field and believes that Family Strengthening is so critical, now more than ever during these unprecedented times.

## News

### FRC's Included in the State Budget

#### FRC Funding with the Department of Developmental Services

Community Navigators - The budget includes \$5.3 M (\$3.2 M General Fund) for the Department of Developmental Services to contract with FRCs to implement a navigator model statewide. The model would utilize parents of individuals in the regional center system to provide education on resources, advocacy, and mentorship to other parents of individuals being served by the regional center system. The purpose of navigators is to increase service authorization and utilization in diverse communities, furthering health equity within the developmental services system. Funding includes resources for a one-time independent evaluation focused on improving the effectiveness of existing disparity projects.

#### COVID Support for Child Welfare Services

Covid 19 Related Supports for Child Welfare Services - the budget includes \$61.1 M General Fund in 2021-2022 to support services related to quarantine needs for foster youth and caregivers, temporary extension of assistance payments to emergency caregivers, support to FRCs, state administered contracts for youth and family helplines, provision of laptops and cellular phones to foster youth, assistance to families with youth who are at risk of entering foster care, and temporary provisions of assistance payments to youth who turn 21 years of age while in extended foster care after April 17, 2020, through December 31, 2021 and for any nonminor dependent who met eligibility requirements for the Extended Foster Care program and lost their employment or has experience disruption in their education program resulting from COVID-19 and cannot otherwise meet any of the participation requirements.
